

One of the regular questions we get from our deposit customers is whether they should list beneficiaries on their accounts. Payable-on-death bank accounts offer an easy way to keep money— even large sums of it—out of probate.

This kind of account has been called the "poor man's trust." POD beneficiaries may also be labeled as 'In Trust For' (ITF), 'As Trustee For' (ATF), Transfer on Death (TOD) or Totten Trust. When you add a POD beneficiary to your bank accounts, you turn your personal account into a type of revocable living trust account. As with any revocable trust account, you can make changes to the account at any time, and you have the right to add or remove beneficiaries. However, the POD designation takes effect as soon as you add the beneficiaries to your account. Thereafter, the named parties have a legal right to funds upon your death. POD designation takes precedence over a will and POD accounts are not treated as part of your estate. After your death, a POD beneficiary can claim the money by providing a certified copy of the death certificate and proof of his or her identity. The bank does not need anything from the probate court. You may need to consult with a lawyer for more guidance on whether a POD will work in your situation.
